2	COMMISSIONER PASSIDOMO SMITH: Okay. Good
3	morning, everyone. Today is October 21st, 2025.
4	It is 9:30 a.m., and I will now call this
5	Prehearing Conference to order.
6	Staff, will you please read the notice?
7	MR. IMIG: By notice issued on October 13th,
8	2025, this time and place been set for Prehearing
9	Conferences in Docket Nos. 20250001, 0002, 0003,
10	0004, 0007, and 10. The purpose of these
11	prehearings is set more fully out more fully in
12	the notice. Sorry.
13	COMMISSIONER PASSIDOMO SMITH: That's okay,
14	Mr. Imig. That's a lot of numbers. Thank you.
15	Let's move to appearances.
16	MR. IMIG: There are six dockets to address
17	today. We suggest that all appearances be taken at
18	once. All should parties enter their appearances
19	and declare the dockets that they are entering an
20	appearance for. Several parties will make
21	appearances. After the parties make their
22	appearances, staff will need to make theirs.
23	COMMISSIONER PASSIDOMO SMITH: Okay. So we
24	will take appearances now beginning with Florida
25	Power & Light.

1	MR. BAKER: Good morning, Commissioner. Joel
2	Baker here on behalf of Florida Power & Light, and
3	I am making an appearance today in the 01, 02, 07
4	and 10 dockets. I would also like to enter
5	appearances for Maria Moncada in the 01, 02 and 07
6	dockets; David Lee in the 01 docket; Will Cox in
7	the 02 docket; and Christopher Wright in the 10
8	docket.
9	Thank you.
10	MR. BERNIER: Good morning, Commissioner.
11	Matt Bernier in the 01, 02, 07 and 10 dockets. And
12	I would enter appearances for Dianne Triplett and
13	Stephanie Cuello in those same dockets.
14	Thank you.
15	MR. MEANS: Good morning, Commissioner.
16	Malcolm Means with the Ausley Law Firm appearing on
17	behalf of Tampa Electric in the 01, 02, 07 and 10
18	dockets. I would also like to enter appearances
19	for Jeff Wahlen in and Virginia Ponder in those
20	dockets.
21	Thank you.
22	MS. KEATING: Good morning, Commissioner.
23	Beth Keating with the Gunster Law Firm here today
24	for FPUC in the 01 and 02 dockets, for FPUC and
25	Florida City Gas in the 03 docket, and for Florida

1	City Gas, FPUC and Sebring in the 04 docket.
2	MR. JONES: Good morning, Commissioner. Matt
3	Jones with the Ausley McMullen Law Firm on behalf
4	of Peoples Gas 03 and 04 dockets. I would also
5	like to enter an appearance for colleagues Jeff
6	Wahlen, Malcolm Means and Virginia Ponder for those
7	same dockets.
8	Thank you.
9	MR. GARNER: Good morning, Commissioner.
10	William Garner for the Southern Alliance for Clean
11	Energy, and I am making an appearance in the 01
12	docket.
13	MS. BAKER: Good morning, Commissioner. Laura
14	Baker of the law firm Stone Mattheis Xenopoulos &
15	Brew, appearing on behalf of White Springs
16	Agricultural Chemicals, Inc., doing business as PCS
17	Phosphate White Springs. And I am entering an
18	appearance today in the 01, 02, 07 and 10 dockets.
19	I would also like to enter an appearance on behalf
20	of James Brew and Sarah Newman in those same
21	dockets.
22	Thanks.
23	MR. REHWINKEL: Good morning, Commissioner,
24	Charles Rehwinkel with the Office of Public
25	Counsel. I would also like to enter an appearance

1	for Walt Trierweiler, the Public Counsel, in all
2	dockets today.
3	Thank you.
4	COMMISSIONER PASSIDOMO SMITH: Thank you.
5	MR. IMIG: Yes, for Commission staff, Ryan
6	Sandy in the 01 docket; Jacob Imig in the 02 and 07
7	docket; Zachary Bloom in the 01 and 03 docket; Saad
8	Farooqi in the 04 docket; Timothy Sparks in the 04
9	docket; Carlos Marquez in the 07 docket; Daniel
10	Dose in the 10 docket and Shaw Stiller in the 10
11	docket.
12	MS. HELTON: And finally, Mary Anne Helton is
13	her as your Advisor in all the dockets, along with
14	your General Counsel, Adria Harper.
15	COMMISSIONER PASSIDOMO SMITH: Thank you.
16	Let's move to preliminary matters.
17	MR. IMIG: Staff notes of that FIPUG and Nucor
18	have been excused from the 01, 02 and 07 and 10
19	dockets.
20	COMMISSIONER PASSIDOMO SMITH: Okay. So for
21	that order of dockets, it's going to be as follows:
22	We will do 02 first, followed by 03, 04, 07, 10 and
23	then we will finish with the 01. So now we are
24	going to let's proceed to the 02.
25	Mr. Imig, are there any preliminary matters we

1	need to address before we get to the draft
2	Prehearing Order?
3	MR. IMIG: No, Commissioner.
4	COMMISSIONER PASSIDOMO SMITH: All right.
5	Seeing none, we are going to proceed through the
6	draft Prehearing Order. As a preface for all of
7	these, I'm just going to move through some of this
8	kind of quickly, especially in the beginning. If
9	there is any issues, feel free to yell out to me
10	and I will slow down and make the amendments as we
11	need.
12	So with that being said, let's move Section
13	I is the Case Background.
14	Section II, Conduct of Proceedings.
15	Section III, Jurisdiction.
16	Section IV, Procedure for Handling
17	Confidential Information.
18	Section V, Prefiled Testimony and Exhibits,
19	staff.
20	MR. IMIG: We recommend that the testimony
21	summary of any unexcused witness be limited to
22	three minutes.
23	COMMISSIONER PASSIDOMO SMITH: Is there any
24	objection?
25	Okay. Seeing none, let's move to Order of

1	Witnesses.
2	MR. IMIG: If the parties are willing to
3	excuse witnesses, staff will confirm with each
4	Commissioner whether a particular witness may be
5	excused. If no Commissioner has any questions for
6	those witnesses, then the witnesses should be
7	excused from the hearing and his or her testimony
8	and exhibits entered into the record as though
9	read.
10	COMMISSIONER PASSIDOMO SMITH: So now I am
11	going to ask parties, is there any witnesses that
12	we have right now that can be stipulated and
13	excused at this time? That's okay, we can you
14	can let us know later if you are still working on
15	that. No problem.
16	All right. We are going to keep moving on to
17	Basic Positions. Are there any changes do any
18	parties have any changes to basic positions at this
19	time?
20	Seeing none
21	MR. REHWINKEL: Commissioner
22	COMMISSIONER PASSIDOMO SMITH: Oh, sorry.
23	Yes, Mr. Rehwinkel.
24	MR. REHWINKEL: Yes, the Public Counsel filed
25	an amended prehearing statement, and I am not sure

1	that our basic position is
2	MR. IMIG: I can address that directly.
3	MR. REHWINKEL: Yeah.
4	MR. IMIG: Yeah, we did receive that. We will
5	make sure that that is updated in the final order.
6	MR. REHWINKEL: Okay. And so for any of the
7	dockets where there is a prehearing order draft
8	that doesn't have what we submitted, I think we did
9	it on Friday, I am not going to repeat this, but I
10	just assume that staff will put it in. I apologize
11	for the lateness.
12	COMMISSIONER PASSIDOMO SMITH: No, that's
13	okay. It sounds like staff is going to make sure
14	it will be in before the final prehearing order is
15	issued.
16	MR. IMIG: That is correct.
17	COMMISSIONER PASSIDOMO SMITH: All right.
18	Sounds good.
19	Okay. Let's go to Issues and Positions.
20	MR. IMIG: Issues and positions are included
21	in the draft Prehearing Order. Staff notes that
22	for issues in which a party has taken no position
23	at this time, if a party does not take a position
24	on these issues per the OEP, their positions will
25	be changed to no position in the Prehearing Order.

1	If a party fails to take a position on an
2	issue by the prehearing conference, the party
3	waives its opportunity to conduct cross-examination
4	on the issue, as well as file a post-hearing brief
5	on that issue.
6	COMMISSIONER PASSIDOMO SMITH: Okay. Parties
7	are there any other related matters here that need
8	to be discussed before we move on?
9	Seeing none, let's move to the Exhibit List.
10	Staff.
11	MR. IMIG: Staff has prepared a Comprehensive
12	Exhibit List that includes all prefiled exhibits,
13	and also includes those exhibits staff wishes to
14	include in the record. Staff will check with the
15	parties before the hearing to determine whether
16	there are any objections to the Comprehensive
17	Exhibit List.
18	COMMISSIONER PASSIDOMO SMITH: Okay. All
19	right. Proposed Stipulations.
20	MR. IMIG: There are no proposed stipulations
21	at this time.
22	COMMISSIONER PASSIDOMO SMITH: Are there any
23	pending motions?
24	MR. IMIG: There are no pending motions.
25	COMMISSIONER PASSIDOMO SMITH: Any pending

1	confidential motions?
2	MR. IMIG: There are no pending confidential
3	requests.
4	COMMISSIONER PASSIDOMO SMITH: Awesome. All
5	right. Post-Hearing Procedures.
6	MR. IMIG: If parties agree to waive briefs,
7	the Commission may make a bench decision for this
8	docket.
9	If there are any issues to be briefed, staff
10	recommends post-hearing briefs be no longer than 40
11	pages.
12	COMMISSIONER PASSIDOMO SMITH: Are there any
13	objections to the 40 pages? All right. Seeing
14	none, let's move to Rulings.
15	MR. IMIG: Staff recommends that the
16	Prehearing Officer make a ruling that opening
17	statements, if any, should not exceed three minutes
18	per party.
19	COMMISSIONER PASSIDOMO SMITH: Is that
20	satisfactory? Okay. So opening statements shall
21	be limited to three minutes per party.
22	Also, I don't know, did I need to make a
23	ruling about witness testimony summaries limited to
24	three minutes? If not, that is my ruling.
25	MS. HELTON: That's set out in the body of the

1	order so
2	COMMISSIONER PASSIDOMO SMITH: Okay. I don't
3	need to make an official ruling? Okay. So just
4	all right, thank you. I will know that going
5	forward.
6	All right. Other matters?
7	MR. IMIG: There are none.
8	COMMISSIONER PASSIDOMO SMITH: Okay. Any
9	other issues in this docket before we move on?
10	All right. So this concludes the prehearing
11	in the 02.
