6	Order?
7	MR. DOSE: Staff is unaware of any preliminary
8	matters at this time.
9	COMMISSIONER PASSIDOMO SMITH: Any party have
10	any preliminary matters in this docket?
11	All right. We will move through the draft
12	Prehearing Order.
13	Section I is the Case Background.
14	Section II, Conduct of Proceedings.
15	Section III, Jurisdiction.
16	Section IV, Procedure for Handling

18	Section V, Prefiled Testimony and Exhibits.
19	Staff.
20	MR. DOSE: Staff suggests that the witness
21	summary testimony be no longer than three minutes.
