Dear Mr. Schrade:

Staff has reviewed Indian Springs Utilities, Inc.'s response to its November 4, 2025 deficiency letter. As discussed during our December 09, 2025 conference call, the updated territory map provided on November 15, 2025, does not correspond to the previously provided territory description; therefore, we find the application to still be deficient. The specific deficiencies identified are:

1. **Legal Description:** Rule 25-30.035(10), Florida Administrative Code (F.A.C.), requires a legal description of the proposed service area in the format prescribed in Rule 25-30.029, F.A.C. Please provide a legal description that meets the requirements identified by this Rule.
2. **System Map.** Rule 25-30.035(14), F.A.C., requires the applicant to provide a detailed system map showing the existing and proposed lines and treatment facilities, with the territory proposed to be served plotted thereon. Please provide the required system map corrected to meet these requirements.
3. **Territory Map:** Rule 25-30.035(15), F.A.C, requires an official county tax assessment map, or other map showing township, range, and section with a scale such as 1" = 200' or 1" = 400', with the proposed territory plotted thereon, consistent with the legal description provided pursuant to Rule 25-30.035(10), F.A.C. Please provide the required territory map.
