Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Industrial Power Users Group (FIPUG) requests confidential classification of certain highlighted information provided in response to FL Rising, LULAC, and ECOSWF's renewed 1st set of interrogatories.

Based on staffs review, the information provided in response to FL Rising, LULAC, and ECOSWF's renewed 1st set of interrogatories, specifically No. 6, contains information relating to competitive interests, the disclosure of which would impair the competitive business interests of FIPUG. Foremost, FIPUG relies on confidentiality of membership in order to retain a diverse association of competitive business entities that have a specific interest in the cost of energy. Furthermore, it would negatively affect FIPUG's ability to recruit and retain members. Therefore, staff recommends that the request for confidentiality of certain information included in Document No. 13640-2025 be approved pursuant to Section 366.093(3)(e), F.S.
