**FLORIDA POWER AND LIGHT COMPANY'S  
REQUEST FOR CONFIDENTIAL CLASSIFICATION**

Pursuant to Section 366.093, Florida Statutes ("Fla. Stat."), and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company ("FPL") hereby requests confidential classification of certain information ("Confidential Information") contained in its December 2025 Earnings Surveillance Report ("December 2025 ESR"). In support of this request, FPL states as follows:

1. On February 13, 2026, FPL filed the December 2025 ESR. Portions of Schedule "D" to the December 2025 ESR contain confidential information. Accordingly, FPL files this Request for Confidential Classification.

2. The following exhibits are included with this Request:

- a. Exhibit A is a copy of Schedule D to FPL's December 2025 ESR on which all the information FPL asserts is entitled to confidential treatment has been highlighted.
- b. Exhibit B is a copy of Schedule D to FPL's December 2025 ESR on which all the information FPL asserts is entitled to confidential treatment has been redacted.
- c. Exhibit C is a table that identifies the information for which confidential treatment is sought and references the specific statutory basis for the claim of confidentiality.
- d. Exhibit D is the declaration of Tiffany Cohen in support of this Request.

3. The Confidential Information is intended to be and has been treated by FPL as private, its confidentiality has been maintained, and its disclosure would cause harm to FPL and its customers. Pursuant to Section 366.093, Fla. Stat., such materials are entitled to confidential treatment and are exempt from the disclosure provisions of the public records law. Thus, once the Commission determines that the information in question is proprietary confidential business information, the Commission is not required to engage in any further analysis or review such as weighing the harm of disclosure against the public interest in access to the information.

4. As described in the declaration attached as Exhibit D, the Confidential Information contains contractual data, the disclosure of which would impair the efforts of FPL or its vendors to enter transactions for services on favorable terms. This information is protected by Section 366.093(3)(d), Fla. Stat.

5. Upon a finding by the Commission that the Confidential Information is proprietary confidential business information, the information should not be declassified for a period of at least eighteen (18) months and should be returned to FPL as soon as the information is no longer necessary for the Commission to conduct its business. *See* Section 366.093(4), Fla. Stat.

**WHEREFORE**, for the reasons set forth above, as more fully set forth in the supporting materials, Florida Power & Light Company respectfully requests that its Request for Confidential Classification be granted.


