5 for a grandfather wastewater certificate in Citrus
6 County by Indian Springs Utilities, Incorporated,
7 including rates and charges. Indian Springs
8 provides wastewater service to approximately 182
9 residential and three commercial customers. Water
10 service is provided by the City of Crystal River.

11 The utility was previously under the
12 jurisdiction of the Board of County Commissioners
13 of Citrus County, which passed a resolution in 2024
14 making privately owned water and wastewater
15 utilities in Citrus County subject to Chapter 367,
16 Florida Statutes. Indian Springs filed an
17 application for a grandfather wastewater
18 certificate in 2024 after the Commission
19 acknowledged the resolution.
