On January 7, 2026, Duke Energy Florida, LLC (DEF or Company) filed a request for confidential treatment of Document No. 00103-2026. This document contains certain confidential information provided in response to Staff's First Set of Interrogatories (ROG) No. 20. This document can be described as information related to DEF's transmission system planning, including load and generation assumptions.

In its request for confidentiality, DEF asserts that disclosure of this information would harm DEF, as the information relates to proprietary confidential business information. Furthermore, DEF states that the Company treats the confidential information provided in Document No. 00103-2026 as private and has not publicly disclosed it. The Company asserts that if this confidential information was disclosed, it may impair the Company's competitive business.

Staff has reviewed the documents and concurs with DEF that the nature of the information meets the requirements set forth in Section 366.093(3)(e), Florida Statutes, whereby disclosure of the information would impair its competitive business interests. Therefore, staff recommends the request for confidential classification of DEF's response to Staff's First ROG, No. 20 in Document No. 00103-2026 be approved.
