

Pursuant to Section 366.093, Florida Statutes (F.S.), and Rule 25-22.006, Florida Administrative Code, Tampa Electric Company (TECO) requests its first extension of confidential classification of certain information contained in the Company's Response to OPC's First Request for Production of Documents (Nos. 1-2), served on April 5, 2024. TECO requests confidentiality under Section 366.093(3)(d), F.S.: "Information concerning bids or other contractual data, the disclosure of which would impair the efforts of the public utility or its affiliates to contract for goods or services on favorable terms."

The information for which TECO seeks confidentiality can be described as engineering consulting contract pricing for Storm Protection Plan development. Staff has reviewed the information that TECO has filed, as well as its confidentiality request, and believes the information that is the subject of the request meets the criteria for confidentiality under the sections requested.
