Notice is hereby given that Sunshine Water Services Company, has filed a Petition with the Florida Public Service Commission on February 27<sup>th</sup>, 2026, to establish rate base value of acquired utility system using the alternative procedure as set forth in Section 367.0811, Florida Statutes. The five-year projected rate impact analysis submitted with the Petition reflects that the acquisition of the Placid Lakes Utilities, Inc. system by Sunshine Water Services Company will manage rate impacts for the customers of Placid Lakes Utilities, Inc., potentially resulting in a rate decrease as customer rates are consolidated with Sunshine Water Services Company's rates in a future rate case proceeding.
