Attached for filing with the Commission is the above-referenced Application of Kinetic ABS FL LLC (“Applicant”).


Pursuant to Florida Stat. §§ 364.183(1) and 364.183(3), Applicant respectfully requests confidential treatment of the financial information provided as **Confidential Exhibit C** to the Application. **Confidential Exhibit C** contains Kinetic ABS FL LLC’s balance sheet and *pro forma* statements of income and cash flows. This information is not publicly available, is commercially sensitive, and consists of information relating to competitive interests, the disclosure of which could impair the competitive business of Kinetic ABS FL LLC.¹ Disclosure could cause harm to the company’s business operations.

The confidential information is being sent via overnight delivery in a sealed envelope and contains two copies of **Confidential Exhibit C**, one of which has been highlighted to show the specific information that Applicant considers to be proprietary confidential information pursuant to Florida Admin. Code § 25-22.006(5). Two redacted copies of the application are also included. Finally, a check in the amount of \$500 is enclosed for the filing fee.
