By this letter, the Commission staff requests that CSWR-Florida Utility Operating Company (CSWR) provide responses to the following data requests:

 - a. For each relevant system, please provide details of the work performed for each Disinfection System project that exceeded \$5,000.

 - c. For each relevant system, please provide details of the work performed for each Electrical System project that exceeded \$10,000.
 - d. For each relevant system, please provide details of the work performed for each Site Improvements project that exceeded \$10,000.
 - e. For each relevant system, please provide details of the work performed for each Tank project that exceeded \$10,000. As part of this response, please identify the tank type (hydropneumatic or storage) and capacity, if changed, and indicate if the tank has been relocated from its previous site.
