2 CHAIRMAN SMITH: Okay. Moving to Item No. 2.
3 Ms. Augspurger, you are introducing the item. You
4 are recognized.

5 MS. AUGSBURGER: Good morning, Commissioners.
6 Jennifer Augspurger with the Office of General
7 Counsel.

8 Item 2 is a rulemaking docket related to the
9 Commission's water and wastewater rules. As part
10 of the Commission's five-year review of its rules
11 under Section 120.54 35, Florida Statutes, the
12 Commission determined that certain water and
13 wastewater rules needed to be amended to provide
14 needed -- necessary updates and clarification,
15 thus, staff is recommending the amendment of Rule
16 25-30.115 of the Florida Administrative Code to
17 amend the rule's language to incorporate by
18 reference the most current version of the National
19 Association of Regulatory Utility Commissioners
20 Uniform System of Accounts for water and for
21 wastewater utilities.

22 In light of this rule amendment, staff is also
23 recommending the amendment of eight additional
24 Commission rules to incorporate by reference the
25 updated NARUC USOA.

1 Additionally, staff is recommending the
2 amendment of Rule 25-30.433 of the Florida
3 Administrative Code to reference the most current
4 Code of Federal Regulations provision incorporated
5 by reference in the rule.

6 Several water and wastewater rules, and
7 specifically 25-30.0372 of the Florida
8 Administrative Code, entitled Alternative Procedure
9 for Establishing Rate Base Value of Acquired
10 Utility System required amendment to reflect
11 current Commission practice and procedure.

12 Staff is available for questions.

13 CHAIRMAN SMITH: Thank you.

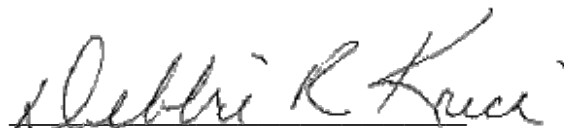
