6 Sapoznikoff with the Office of General Counsel.

7 Item 3 is staff's recommendation regarding
8 proposing the amendment of three rules and
9 proposing the repeal of four rules. These
10 recommended changes are the result of staff's
11 assessment of these rules during the five-year rule
12 review process required by Section 120.5435,
13 Florida Statutes.

14 The recommended amendments simplify, clarify
15 and update the rules. In particular, the
16 amendments to Rules 25-6.003 and 25-30.255, delete
17 references to materials incorporated by reference
18 that are no longer relevant. And amendments to
19 Rule 25-30.434 substitute a new form, which is
20 incorporated by reference, and which is necessary
21 to reflect the Commission's current practice and
22 procedure. The recommended repeals are for
23 unnecessary or repetitive rules.

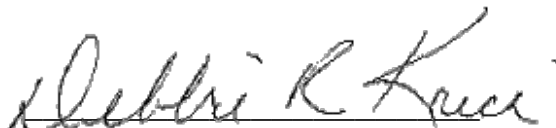
