2 CHAIRMAN SMITH: And Item No. 12, Ms. Guffey,
3 when you are ready.

4 MS. GUFFEY: Good morning, Chairman and
5 Commissioners. Seveni Guffey with the Division of
6 Economics.

7 Item 12 is Duke Energy Florida, LLC's,
8 petition for a limited proceeding seeking
9 Commission approval of a new large load customer
10 policy and associated large load customer
11 agreement.

12 Duke Energy is also requesting Commission
13 approval to revise its contributions in aid of
14 construction tariffs. Specifically, DEF proposed a
15 new policy and an agreement to establish minimum
16 contract term, monthly bill provisions, security
17 requirements and early termination provisions.

18 Additionally, the contributions in aid of
19 construction tariff provision in the LLCP requires
20 large load customers to pay 100 percent of
21 estimated cost to extend service in advance.

22 This recommendation is to suspend the proposed
23 tariffs to provide staff and the parties time to
24 analyze and request the Commission to conduct a
25 hearing on this matter. The hearing is currently

1 scheduled for August 25th and 26th.

2 Participation is at the discretion of the
3 Commission, and staff is available for any
4 questions.

5 CHAIRMAN SMITH: Thank you, Ms. Guffey.

8 COMMISSIONER CLARK: Move to approve the
9 tariff suspension, Madam Chair.

10 COMMISSIONER LA ROSA: Second.
