SECTION 63.71 APPLICATION OF VERIZON

The competitive local exchange companies filing this petition (collectively, “Verizon”) apply for authority under 47 U.S.C. § 214(a) and 47 C.F.R. § 63.71 to discontinue the following services provided throughout the contiguous United States (48 states and the District of Columbia) (the “discontinuance area”): Integrated Services Digital Network Primary Rate Interface (ISDN PRI), Full T1 Service, Digital PBX Trunks, and Virtual Foreign Exchange (VFX) (the “affected services”).

INTRODUCTION

With this application,¹ Verizon seeks to discontinue the affected services throughout the discontinuance area on or after July 31, 2026. These services have few customers; discontinuing them will enable current customers to move to better services and serve as an important step toward meeting both Verizon’s and the Commission’s goals of providing the next-generation

technologies that American consumers want.

Demand for these affected services is very low, and the few remaining customers in the discontinuance area have many cost-effective alternative options to choose from as replacements. In total, Verizon has as few as 1 and no more than 73 customers per state throughout the contiguous United States that are using any of the services that Verizon seeks to discontinue. In total, approximately 510 customers will be impacted by this discontinuance.

In the discontinuance area, existing and prospective customers of these affected services have access to cost-effective alternatives through Verizon's fiber-based services and other Verizon products that are superior to the affected services. In addition, there are many competitive services available in the discontinuance area, which many businesses have already selected in lieu of the affected services. These available alternatives include services offered over cable, fiber, fixed wireless, mobile wireless, and satellite technologies. After discontinuance, Verizon will no longer offer these services in the affected service area.

II. Date of Planned Service Discontinuance

Effective on or after July 31, 2026, pending regulatory approval, Verizon will discontinue the affected services.

III. Points of Geographic Areas of Service Affected and Description of the Affected Service Area

Verizon plans to discontinue the affected services throughout the area where the Verizon entities submitting this application provide service in the contiguous United States (48 states and the District of Columbia).

IV. Brief Description of Type of Service Affected

A. Integrated Services Digital Network Primary Rate Interface (ISDN PRI)

Integrated Services Digital Network Primary Rate Interface (ISDN PRI) is a T1-based service (1.544 Mbps), typically providing 23 voice channels and one signaling channel, including: Local ISDN-PRI, including Flat Rate Local ISDN PRI & Long-Distance ISDN PRI packages.

B. Full T1 service

Full T1 service is a dedicated 1.544 Mbps connection supporting 24 channels for voice or data, including Full T1 Service / Local T1, including Local & Long-Distance ISDN PRI packages.

C. Digital PBX Trunks

Digital PBX Trunk Service is a T1-based connection linking private phone systems to the public network, including Local Trunk Flat Rate (All Trunk Types) - Per Trunk, Local Trunk

Rate Bundled Local and Long Distance - Per Trunk, Local Trunks Basis, Local Trunk DID,
Local Trunk 2 way direct.

D. Virtual Foreign Exchange (VFX)

Virtual Foreign Exchange Service is a T-1 based service that provides connectivity to a switch outside a customer's local exchange area.

V. Brief Description of the Dates and Method of Notice to All Affected Customers

Customer notices were sent by U.S. Mail on June 4, 2026, to Verizon customers of the affected services located in the discontinuance area. A representative example of the customer notice is attached as Exhibit A.

Copies of this Application are being sent via first-class U.S. Mail to the governor, public utility commission, federally recognized tribes (if any) in the discontinuance area, and to the Special Assistant for Telecommunications to the Secretary of Defense, as required by Section 63.71(a) of the Commission's rules.²

VI. Regulatory Classification of Carrier

Verizon offers these affected services pursuant to non-dominant carrier regulation.

VII. Public Convenience and Necessity

The public convenience and necessity will not be impaired by the discontinuance of these services. Current customers in the discontinuance area have many options to choose from in lieu of these services that will be discontinued. Customers today can obtain alternative services and products from Verizon or other providers that may suit customers' needs depending on the

customers' particular applications. Possible alternatives offered by Verizon include IP Integrated Access (IPIA), Fixed Wireless Access (FWA), Webex Calling, and One Talk. Verizon will work with affected customers to find suitable alternative solutions.

Because there are numerous cost-effective, superior alternatives for prospective customers in the discontinuance area to choose from, and because most customers have already left for such alternatives, discontinuing the affected services in this area will not impair the public convenience or necessity.

As previously communicated, Verizon is retiring certain legacy TDM-based services as part of our network modernization efforts. This transition will enable access to newer technologies that offer faster speeds, improved reliability, and more consistent performance.

These services will be discontinued in the contiguous United States (48 U.S. states) and Washington D.C.

IVR, long distance, and toll-free services are not affected by this change. However, if these services currently run over the TDM services being discontinued, you will need to move

those connections to an IP-based or switched solution to avoid disruption.
