Dear Mr. Teitzman:

Enclosed is a paper copy of one of the actual confidential Hearing Exhibits, identified in the Comprehensive Exhibit List ("CEL") as Hearing Exhibit 487. It was identified in Case Center as "OPC-2C." CEL Exhibit No. 487 was used at hearing and admitted into evidence on October 8, 2025, as shown in volume 5 of the hearing transcript, page 956, in Docket No. 20250011-EI. Due to a misunderstanding, all copies of the documents distributed to the Commission personnel were collected by the OPC at the conclusion of the day's hearing session. This meant that the physical copy of the document was not retained in the official files of the agency for purposes of compiling a record for appellate review. Because of the appeal of the orders in this docket, this exhibit is needed for completion of the designated record to be transmitted to the Florida Supreme Court.

I contacted counsel for FPL, and she has confirmed that the confidential documents from which Exhibit 487 was assembled – Response to OPC POD No. 50 (and thus the exhibit itself) – is covered by Order No. PSC-2025-0237-PCO-EI, issued June 24, 2025.

In order to support the requested stipulation to include Exhibit No. 487 in the record compilation, I am also providing to the parties participating in the appeal in SC2026-0259 an exact copy of the exhibit source file(s) from which Exhibit No. 487 was created at the time of hearing. A scanned copy of the paper copy I am providing to you will not copy suitably given the light grey typeface used in the original document combined with the limitations of our document scanner. I will nevertheless provide that scanned copy to the parties in the event it will aid in their confirmation and stipulation that the paper copy I am providing to the Commission is a genuine
