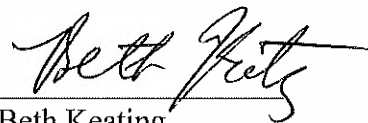

Florida City Gas (“FCG”) submits this Errata Sheet to Company witness Noah Russell’s Direct Testimony, originally filed on April 20, 2026.

Page 5, line 8: change “the Company’s” to “Chesapeake’s”.

Page 8, lines 18 and 20: change “the Company’s” to “Chesapeake’s”.

Page 13, line 11: Change “the Company’s” to “Chesapeake’s”.

Page 15, line 12: change “overstate” to “understate”.

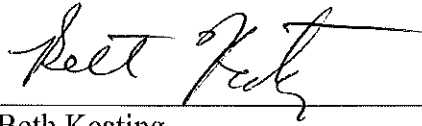
Page 15, line 13: change “increase” to “decrease”.

Page 22, line 20: change “the Company” to “Chesapeake”.

Page 39, lines 7-8: Following the word “debt,” **delete** “FCG was acquired with one hundred percent equity and carries no associated debt” and **replace** with “FCG did not have any third-party debt outstanding and did not assume any acquisition debt in connection with the acquisition”.

Page 39, lines 8-9: **Delete** “No third-party debt arrangements existed at the FCG level at the time of the acquisition.” **Replace** with “Although Chesapeake financed the acquisition using a combination of debt and equity at the parent company level, that debt was incurred and remains at the Chesapeake level and is not an obligation of FCG.”

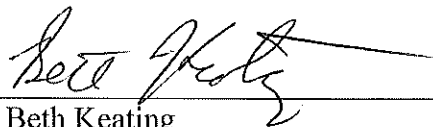
