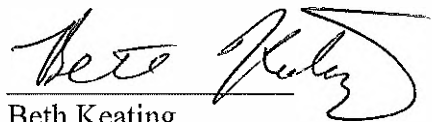

Errata to the Direct Testimony of David Haag (April 20, 2026)

Florida City Gas ("FCG") submits this Errata Sheet to Company witness David Haag's Direct Testimony, originally filed on April 20, 2026.

Page 48, line 21 through line 22: After "if the" in line 21, remove the following language, "the depreciation rates (including the Reserve Surplus Amortization Mechanism)," such that the sentence that begins on line 21 reads as follows:

In addition, I note that if the applicable capital structure, or other major cost of service components are not approved as filed in this proceeding, FCG's risks may further increase, which may necessitate an additional upward adjustment above this level for ratemaking purposes in this proceeding.
