23 Staff is recommending minor amendments to all
24 the rules to update the rule language to make them
25 more readable and reflect current practice.

1 In addition, staff's recommended amendments
2 remove obsolete references and update the rules to
3 reflect current widely accepted accounting
4 guidelines.

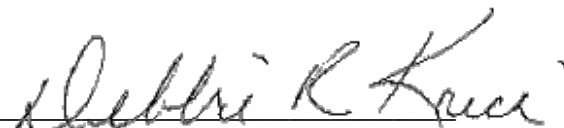
