Dear Mr. Self and Mr. Smith:

By this letter, the Commission staff requests that Coastal Connect Services, LLC (CCS) provide responses to the following data requests:

1. Does CCS have an ownership interest in SpaceX? If so, what is that interest?
2. Refer to paragraph 7.5 of the proposed Firm Transportation Service Agreement as well as to CCS's responses to Staff's First Data Request Nos. 1, 2, and 19. Confirm that paragraph 7.5 of the proposed Firm Transportation Service Agreement would not divest the Florida Public Service Commission (Commission) of regulatory oversight authority or preclude it from applying Florida law to disputes, claims, or causes of action in which the Commission otherwise has competent jurisdiction to hear and address.
3. Are the rates contained in the proposed Firm Transportation Service Agreement based on CCS's cost to own and operate the pipeline? Please explain.
