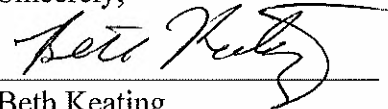

**FLORIDA PUBLIC UTILITIES COMPANY'S

ESTIMATED/ACTUAL TRUE-UP AMOUNT**

Florida Public Utilities Company (FPUC or Company), by and through its undersigned counsel, hereby files this Petition asking the Florida Public Service Commission (FPSC or Commission) for approval of FPUC's fuel adjustment and purchased power cost recovery estimated true-up amount for the period January 2026 through December 2026. In support of this request, the Company hereby states:

- 1) FPUC is an electric utility subject to the Commission's jurisdiction. Its principal business address is:

- 3) Consistent with the requirements for this proceeding, the Company has prefiled the fuel adjustment and purchased power cost recovery true-up forms supplied by the Commission consistent with the requirements for such filings.

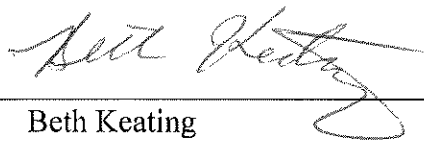
4) In accordance with Order No. PSC-2026-0037-PCO-EI, issued February 6, 2026, the Company is also submitting, contemporaneously with this Petition, the Direct Testimony and Exhibit CWM-1 of Ms. Caroline Wanjiru McCool in support of the Company's request for approval of the requested actual/estimated true-up amount.

5) As noted in the Company's April 3, 2026 filing, the final remaining true-up amount for the period ended December 2025 is an under-recovery of \$906,830, an actual, end of period over-recovery \$2,305,144, compared to the Company's projected over-recovery of \$3,211,973.

6) Based on 6 months of actual data and 6 months of estimated data, the estimated true-up amount for the period January 2026 through December 2026, is an estimated under-recovery of \$1,434,408 for a total end of period under-recovery of \$ 2,341,237.

WHEREFORE, FPUC respectfully requests that the Commission approve the estimated/actual true-up amount for January 2026 through December 2026 as an under-recovery of \$\$1,434,408 resulting in a total over-recovery of \$2,341,237.
