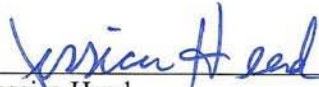

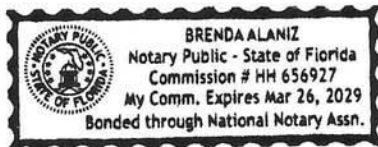

By Order No. PSC-2026-0235-PAA-WS, issued June 23, 2026, in Docket No. 20250146-WS, the Florida Public Service Commission (Commission) approved an application for transfer of water Certificate No. 354-W and wastewater Certificate No. 310-S from Useppa Island Utilities Company, Inc. (Useppa Island) to UIP Utilities Company LLC (UIP) in Lee County. The monthly water and wastewater rates and charges you were paying to Useppa Island will remain unchanged unless and until a change is approved by the Commission.
