5 This is Patrick Kelley with the Division of
6 Economics.

7 Item 10 is Tampa Electric Company's petition
8 for approval of revised underground residential
9 distribution tariffs. These tariffs apply to new
10 residential subdivisions and represent the
11 additional costs, if any, TECO incurs to provide
12 underground distribution service in place of
13 overhead service.

14 TECO's proposed underground per service
15 lateral distribution -- or cost distributions for
16 low and high density subdivisions remains at zero
17 dollars. Based on our review of the information
18 provided, staff believes that the proposed tariffs
19 are reasonable and recommends Commission approval.

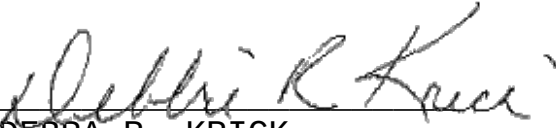
